WHERE IS MY HERALDRY SUBMISSION?

2006 was a great year for Shire members in submitting names and armory for registration by the SCA College of Arms. I think that everything that Shire members submitted passed Kingdom and was included in one of the many Letters of Intent composed by the Ruby Herald of Gleann Abhann.

Once a Letter of Intent (LoI) is sent out, the names and armory on it are usually decided upon by the Laurel Sovereign of Arms, Pelican Sovereign of Arms, and Wreath Sovereign of Arms at their respective meetings four months from the date of the LoI. So the submissions in a LoI dated December 14, 2006 would be decided in April 2007. The decisions made by the Sovereigns of Arms are published in the Letter of Acceptance and Return (LoAR). The LoAR goes through a proofreading process so may not come out until one or two months (or longer) after the meeting at which the decisions were made.

Below is a table showing the submissions made by Shire members in 2006, the date of the LoI composed by the Ruby Herald that the submissions are in, and the month at which the Sovereigns of Arms would make a decision on the submissions. I cannot tell you how quickly you will learn what were decided, but at least everyone will know when a decision should have occurred.

Nineteen people have held the office of Herald of the Shire over its twenty-five plus years history, but only four have served longer than one year as Herald. At the beginning a lot of the local members were in school. As they graduated or transferred to other colleges, vacancies occurred. One person even moved to Hawaii! Most of the time someone was willing (and sometimes was currently being trained as the replacement) to take on the office, but occasionally the Seneschal had to file reports until a new member joined or old member moved to the Shire and volunteered or was coerced through much begging and pleading to become the next local herald. Diarmuid was the first herald of record for the Shire and sought a lot of advice from Oreta Heineman, Beacon Principal Herald from 1980 – 1982, and Lachlan Sinclair Dumas, Beacon Principal Herald from 1982 – 1984. Pennon Heralds who may have assisted with the registration of the Shire's name and device between 1980 and 1982 were Domenica Farnese and Brigit Olesdottir of Loch Ree. Both Diarmuid and Danica held the local office twice, Diarmuid for a cumulated duration of two and half years and Danica for almost four years. Olaf, the last person to hold the office longer than one year, held the office for almost two years. The longest the office of Shire Herald has been held by one person at one time is almost ten years. Rory held the office for 115 months.

Several of the Shire's Heralds have served in heraldic offices to the Kingdom of Meridies and Kingdom of Gleann Abhann. Danica was the first Western Reporting Deputy Herald for the Kingdom of Meridies. She received the monthly reports from every local herald in the west side of Meridies. She held this office from May 1987 to June 1988. Rory was the last Western Reporting Deputy Herald for the Kingdom of Meridies, holding the office from April 1993 to January 1995 when the Region of Gleann Abhann was formed. The West Region Herald, titled Obsidian Herald in January 1995, was first held by Mistress Sionyn. The West Region Herald was the Head Herald of the Region. The title of this office changed from Obsidian to Diamond Herald in January 1998. Rory served as the first Ruby Herald (Submissions) for the Region of Gleann Abhann from January 1995 to June 1996, the Lambent Herald (Commenting on Letters of Intent) for the Kingdom of Meridies from September 1993 to December 1995, and Pennon Herald (Submissions) for the Kingdom of Meridies from May 1996 to May 1998. Richard Stewart of Saint Andrews is the only member of Ardanroe to serve as a Principality Herald for Gleann Abhann, serving as the Obsidian Herald, now in charge of the court heraldry and the Order of Precedence not local monthly reports, from December 2003 to November 2004. Richard was the first Fire Opal Herald of the Kingdom of Gleann Abhann, created when the duties of the Obsidian Herald were divided into two jobs. As Fire Opal, Richard was in charge of court heraldry, from November 2005 to October 2006. Sarah MacGregor is the second member of Ardanroe to serve as the Obsidian Herald, though she is the first Obsidian Herald for the Kingdom of Gleann Abhann, assuming the office in November 2005. As the Obsidian Herald she is in charge of maintaining the Order of Precedence.

A BRIEF HISTORY OF MONTECASSINO

I am happy to present a brief history of Montecassino, the town and abbey, from which Lady Beatrix de Montecassino's persona originates. The information comes from the *Encyclopaedia Britannica* and the website for the *Abbey of Montecassino*. As you consider a persona to create within the enormous time span covered by the Society for Creative Anachronism, think about not only the culture or country you want to come from but also the town where you originated or which was a focal point for your persona history.

Casinum was a town of the ancient Volsci people located along the Rapido River at the foot of Monte Cassino some 87 miles southeast of Rome. The Romans took control of the town in 312 BC. Monte Cassino Monastery was founded by Saint Benedict in 529 on the remnants of a Roman fortification of the *municipium Casinum*. The temple of Apollo still being used by the locals became the oratory of the abbey dedicated to Saint Martin Bishop of Tours. Casinum, Latin for Cassino, was one of many surrounding municipalities which fell under the pastoral jurisdiction of the Abbot of Monte Cassino. The Monte Cassino Monastery became known as the site of the founding of the Benedictine Order, where Saint Benedict completed writing his *Regula monachorum*. Saint Benedict died in the Saint Martin oratory around the age of 70, the date traditionally established as March 21, 547. Both he and his sister, Scolastica, rest beneath the high altar located elsewhere in the monastery.

Around 577 the monastery was destroyed by the Longobards of Zotone, Duke of Beneventum, but early in the eighth century the Brescian Petronace was commissioned by Pope Gregory II to rebuild it. Charlemagne visited the abbey in 787. In 866 the townspeople of Casinum abandoned the original site for the town's present location. The new town was originally known as Eulogomenopolis, later San Germano, and since 1871 Cassino. The town was strengthened against invaders by the building of the Rocca Ianula, a fortress in the 9th century. It was at this fortress

that Pope Innocent II in 1139 was captured by Roger II of Sicily and Pope Gregory IX in 1230 made peace with the Holy Roman Emperor Frederick II. Rocca Ianula was sacked by the French troops in 1799.

The monastery also suffered greatly. In 884 the Saracens sacked the monastery followed by the Normans in 1030. Abbot Desiderius, who later became Pope Victor III, was perhaps the most noted abbot at the monastery in the 11th century who worked to rebuild it, bringing in artists from Constantinople. In 1349 an earthquake destroyed much of the monastery and it was almost entirely rebuilt in the 16th and 17th centuries.

In 1944 during War World II the town of Cassino was a key point in the German winter defensive line. Believing the monastery to be occupied by the Germans, the Allied forces bombed it on February 15, 1944. A month later the town of Cassino was leveled with 1400 tons of bombs dropped from Allied aircraft. In mid-May the Allied forces were able to break the German lines and take Rome after being joined by forces from the Anzio beachhead. Both the town and monastery were rebuilt, the town using a completely new layout. Of ancient Casinum the only monuments of note are the amphitheatre, the theatre, and the ruins of the Cappella del Crocifisso, a Roman mausoleum converted into a church in the 10th century. Of the medieval town only the site of the upper town, clustered around the ruins of Rocca Ianula can be discerned. A set of bronze doors cast in Constantinople in 1066 for Abbot Desiderius are one of the few items to survive the second World War from the monastery in addition to its archives, library, and some paintings.

LET'S DANCE!

This month's dance is: Amorosio

If you missed the ball at Christmas Revel you missed the dance of the year! Amorosio is a 15th century Italian balli. Guglielmo Ebreo da Pesaro (also called Giovanni Ambrosio) was one of two major dance choreographers of the time. It is his Amorosio which was spectacularly performed at the ball. Certain items are common in the balli, repetitive structure being most notable. In couples dances usually the lady repeats the steps performed by the lord. Ornamentation and improvisation were considered important to the dances but are not well described. The steps for the Amorosio given below are from the articles by Mistress Rosina del Bosco Chiaro "Fifteenth Century Italian Balli" and Messer Giuseppe Francesco da Borgia "Basic 15c. Italian Renaissance Balli" in *A Known World Dance Compendium* compiled by THL William Redcape of Iron Mountain, A.S. XXXI. Master William Redcape has a different set of steps for the Amorosio in his Gulf Wars 9 Dance Cheat Sheet. Those steps are also given later. Thus be aware that the dance may be different from what was seen at Christmas Revel. But these are the best sources I have for locating instructions for this amazing dance.

The Amorosio is a two person dance. As viewed at Christmas Revel this had several couples in the room each dancing as individual couples but as a group visually balanced and individually stunning. The basic steps given by Messer Giuseppe as what Giovanni Ambrosio wrote are:

8 tempi piva
2 sempii 1 doppio 3 sempii; (repeated by the partner)
4 tempi piva (repeated by the partner)
2 sempii 1 doppio 2 sempii 1 doppio Reverenza 4 tempi piva (the original repeats the last part)

We know that a Reverenza is a reverence, the bow or curtsy to one's partner. A sempii is the plural for sempio, a single. Move one foot forward and bring the other up to meet it in and close. A doppio is a double. The technically fancy way to do it is as follows: Step 1 & 2 is done on the balls of the feet. Step 3 brings you back down. Step 4 is a kick. These are similar but different from the singles and doubles we have done in the dances previously covered in this column.

A piva is a fast doppio. It is a fast set of 3-4 kicks. I believe that tempi is plural for tempo. There were four dance tempos used in the ballo, sometimes all in the same dance. These were bassadanza (usually notated as being in 6/4 in modern arrangements), quadernaria (4/4), saltarello (6/8), and piva (2/4 or 6/8). So if I understand the instructions and steps, the Amorosa starts with the couple doing eight very fast doubles. Then the lord does two singles, a double, and three singles. The lady then does two singles, a double, and three singles. The lord does four very fast doubles. The lady does four very fast doubles. Then the lord does two singles, a double, two singles, a double, reverences to the lady, and then four very fast doubles. The lady repeats this doing two singles, a double, two singles, a double, reverences to the lord, and then four very fast doubles. The couple is now back together and the dance starts all over again with the eight piva.

Master William's listing of the steps are:

8 piva forward. Lord ssdsss, Lady ssdsss, Lord 3 pive, s, Lady 3 pive, s. Lord ssdsss, meza volta, 3 pive, s. Lady ssdsss, meza volta, 3 pive, s. Dance repeats with Lady doing solo parts first.

A meza volta is a partial turn that is usually 180 degrees. So if you have danced away from your partner, you are turning to face your partner when you do a meza volta in the Amoroso.

This version is very similar to the first. The difference is really a reverence versus a meza volta.

The couple together does eight very fast doubles (8 piva or 8 tempi piva). The lord does two singles, a double, and three singles. The lady does two singles, a double, and three singles. The lord does two singles, a double, and three singles and turns to face the lady and does three very fast doubles (3 pive) and ends with a single. The lady does two singles, a double, three singles, and turns to face the lord and does three very fast doubles (3 pive) and ends with a single. The couple is now back together and the dance starts all over again. This time the lady does the solo parts first.

Ornamentation and improvisation is what made this dance so stunning. It can be very courting or seductive. And note that the garb worn by those at the Christmas Revel ball varied based on persona. A Middle Eastern lord and lady as depicted by Lord Khalil and Mistress Isolde were just as elegant (and more so since dance is her area of expertise) as an Italian or English lord and lady depicted by Lord Kenneth and his dance partner.

We should all learn this dance for future balls.

FORTNIGHT

The December Populace Meeting was held on the 16th as part of the Yule Party at Medb's house.
