Fighter Practice & Vellum Making Part III was held at Llifwyr Tyddyn on Saturday, March 6th starting around 2:30 p.m. Avice continued to teach the process of vellum-making and Symon and Skallagrim handled fighter practice. The activities were attended by Jurgis and Suzanne with their two teen-age/tween grandchildren (Scotty and Brittany), Skallagrim, Evlaliiia, Melisant and her two kids (Eric and Elizabeth), Maximilian, Avalina, Ebrahim, Avice, and Symon. Avice and Symon provided the meat dishes for the potluck supper along with water and tea.

The Shire's A&S Night was held on Wednesday, March 24th at the Aulds Branch Library from 7:00 to 8:30 p.m. with fifteen adults and four children attending. Attendees included Dana, Jurgis, Suzanne, Amelia, Melisant, Lorccan, Evlaliiia, Skallagrim, Branwen Bryn-glas, James, Stephen Wolf, Avalina, Ebrahim, Amata, Rory, and the little ones (Melisant's two goslings – Eric and Elizabeth and Branwen's two tween/teens – Tyler and Garrett). Mary Flanders, a friend of Amelia's, was the guest instructor. Mary gave a demonstration on needle point technique, showing samplers done by her father. Participants were able to practice threading needles and begin stitching on practice squares created from old patterns. Copies of the *Recipes of Gleann Abhann* cookbooks were sold to local Shire members.



LOUISIANA STATE PARK PRICES INCREASE

According to State Parks Director Stuart Johnson, as a result of budget cuts the Department of Culture, Recreation and Tourism will be increasing the price charged to keep parks open. New prices will go into effect July 1, 2010.

Entry to state parks will remain \$1, but entry into state historic sites will double from \$2 to \$4.

Current fees of \$16 for standard campsites and \$18 for premium ones will remain during the winter season but will rise to \$20 and \$26 for the summer season, which runs from Memorial Day through Labor Day Weekend.

Standard cabin rentals will jump from \$70 a night to \$85 all year. Deluxe cabin rentals will increase from \$90 to \$100 a night, except on summer season weekends when its \$150.

Lodges, which sleep several people, also will see price hikes in July. The \$125 standard lodge rental will increase to \$140 most nights but \$175 on weekends during the summer season. Deluxe lodge rentals will increase from \$150 to \$160 and \$180 on summer weekends.

Group Camp Class 1, which accommodates up to 49 people, will rent for \$200 a night, instead of the \$150 now charged, Group Camp Class 2 (up to 99 people) for \$250, instead of \$200, and Group Camp Class 3 rentals (100 and more) will rise from \$400 to \$500.

There's also a \$2 increase for using the Bayou Segnette State Park wave pool.

Boat rentals at all state parks will increase from \$15 to \$20 per day.

ADDER'S TONGUE

Ophioglossum vulgatum is also known as Serpent's Tongue and Christ's Spear. There are around 25 to 30 species. Ophioglossum is Greek meaning "snake-tongue". The name is thought to refer to the appearance of the plant's single stalk. The fleshy roots radiate out from the stalk.

The ruling planet is the Moon and astrological sign is Cancer.

This fern could be found growing wild in hedgerows, river banks, and meadows so long as there is moisture. It blooms in April thru May but is heat sensitive. This plant has one leaf on a single stalk. The bright yellow flower is shaped like a lily. It might not flower every year. The roots can exist for years underground due to a symbiotic relationship with soil fungi.

It is used as an astringent and for cleaning ulcerated wounds. It was used to treat gout. It was added to baths for sensitive skin. The only known allergic reactions are in others who also are allergic to tulips and lilies.

CARRIAGE CHATTER

Kingdom Fighter Collegium, February 26-28, Shire of Blackmoor Keep

Kingdom Fighter Collegium was held the last weekend of February at King's Arrow Ranch in Lumberton, Mississippi, by the Shire of Blackmoor Keep (a group located in Lake Charles, Louisiana). Senor Mateo Lopez was the autocrat, assisted by Lord Miles de Warewick. Reservations were handled by Senor Mateo. Lord Broddi Raudskegga was the head cook.

The site token for the event had the appearance of a flat wooden ornament with an arm holding a sword cut out and a black cord used to hang it from belts or tree branches.

The Order of the Chivalry organized the heavy weapons classes coordinated by Sir Drogo of Axbridge. At least nineteen warriors or heralds offered eighteen classes between nine o'clock Saturday morning and five o'clock that evening. Another nine classes were offered for those interested in the light weapons (rapier) organized by the THL Aethan Dunmire.

Despite foul weather Friday night, Maison des Animaux hosted 'Friday Night Fights' as a fundraiser for Their Majesty's Discretionary Fund. The activity was to be held in front of the fort from nine to eleven o'clock that night with a wolf pit (similar to a bear pit) where the challengers would face the Chivalry and a separate pit for the fencers. It would cost ten dollars to take part and the winner, the challenger with the most wins, would receive a prize. There may have been more fencing than heavy fighting due to the weather.

Lunch on Saturday was a fundraiser provided by the Shire of Troll Fen. The Order of the Pelicans held their floating meeting at one o'clock in the Green Dragon. The new Kingdom pavilion was unveiled during the day showing off all of the painted dags bearing the arms of local groups or badges of households, which had been the fundraiser to get a new pavilion.

Court was held indoors. During court the following people were recognized by the Crown: Havordh Aettarbani (King's Champion), Emma del Trees (Grant of Arms), Mika'il al-Rashid (Wreath of Chivalry), Bridie O'Sullivan (Shepherd), Alrekr inn Svarti (Silver Ram and Combattant Ram), Isabella D'Arques (Combattant Ram), Broddi Raudskegger (Onyx Chalice), Mateo Lopez (Onyx Chalice), Miles de Warewick (Onyx Chalice). Baroness Isabella received her honorary induction into the Combattant Ram for her service as list mistress.

Baroness Medb gave a promotional plug for the Gleann Abhann cookbook. The office of Quartermaster transferred from Lord Eduin to THL Mika'il al-Rashid. The Kingdom Seneschal, THL Ravenswar, introduced his new deputy, Mistress Lailiane Asenina, who would become the next Kingdom Seneschal ideally at next year's Fighter Collegium. Last, during court, Duchess Mary Grace of Gatland was surprised with the announcement that she would be elevated to the Order of the Pelican at Gulf Wars.

Feast was bacon-themed with most, if not all, of the dishes containing bacon as an ingredient.

The event was well attended by the Ardanroe populace, including Avice, Symon, James, Sarah, and Maximilian.

Gulf Wars XIX, March 13-21, Kingdom of Gleann Abhann

The nineteenth Gulf Wars event was a full week plus days, starting Saturday, March 13, and concluding Sunday, March 21. Held at King's Arrow Ranch in Lumberton, Mississippi, the attendees were treated to a March madness of weather ranging from a warm sun and cool rain to chilly snow. Shire attendees included Skallagrim, Evlaliia, Maximilian, James, Sarah, Helmut, Jurgis, Suzanne, Branwen Bryn-glas, Johannes and Branwen, and Medb. Many of these fine gentlefolk worked long hours at troll, security, herald's point, as or assisting judges in various arts and sciences competitions and as entourage to the royalty. Several arrived days earlier than the opening day to help set up the site, marking and setting up the different work areas (security, heralds, volunteers, etc.) and fun areas (merchants, artisan's row, etc.). And some even got to fight in the melee battles or tournaments held during the week.

The *Recipes of Gleann Abhann* cookbook was a hit, Baroness Medb selling at least 90 during the war. As of the Shire's A&S Night it was reported there were less than 20 still available for purchase. Copies of the cookbook were included in the gifts to the visiting royalty from the other Kingdoms and Principalities.

Tuesday night was the Gleann Abhann Social and despite threatening weather over half the attendees at Gulf Wars came to the party and enjoyed the food and drink of southern hospitality. For the second year in a row the BBQ contest was held, promoted by Baron Soní Kurái Chikára Hitô. Earl Loric Sylvestris assembled judges from five kingdoms to sample the BBQ. The overall winning team was the Barony of Grey Niche/Team Firestorm, who won or lost each individual contest by less than a single point.

Wednesday evening Duchess Mary Grace of Gatland was placed on vigil. Her elevation to the Order of the Pelican would occur Thursday at the Ansteorran Rose Tourney. As reported by Baroness Barbara, the cloak of Duchess Arielle the Golden of Atlantia, who passed away during the Summer of 2009, was presented to Her Grace I believe as her pelican's cloak.

Thursday evening the Barony of Axemoor held court followed by a vigil-party for Baroness Morgana of the Mist. Morgana's elevation to the Order of the Pelican occurred Friday night between the Great Court of Gulf Wars and the Knowne World Party, dubbed Oktoberfest this year. Morgana being credited as the weather-wizard for the Kingdom had a clear sky filled with stars and a sliver of moon. And in honor of Morgana and her endless supply of handkerchiefs during court, handkerchiefs were supplied to all in attendance.

Saturday evening was the Kingdom of Gleann Abhann's court. Bronwyn the Fair, Queen of the East, gave thanks for the welcome bags to the royalty, the royal liaisons, and presented Mistress Mary-Grace of Gatland with one of the East Kingdom's oldest awards (created in AS IX), the Queen's Order of Courtesy. During court the Barony of Seleone held its investiture as Morgan of Osprey, current Baron of Seleone, was joined by Eugenie Griffon de Seleone as Baroness. Gellis and Brigida of Axemoor received court baronies, Baroness Masheed Leily of Grey Niche was inducted into the Diamond Chalice, and Baron Charles of Axemoor and Mistress Mary-Grace received the Jeweled Horn. And His Majesty William II announced that THLord Caedmon of Jorvik would be knighted at Beltaine. Topping off the evening for the Shire of Ardanroe was the awarding of arms to Helmut for his massive number of hours of service to Kingdom and Crown during the War. Yeah Lord Helmut!

Sunday morning there were snowflakes as everyone packed up to go home. While an official final number has not yet been seen, it is believed that over 3600 gentlefolk attended Gulf Wars this year.





ASK SKALLAGRIM

This is a new column from our new Chatelaine. Please send Skallagrim your questions (we know you have them!). This month there are “Questions from War”.

1. **What do you do with kids during a war?** Again we have a multiple part answer. It seems nothing is simple. The best thing would be to leave them at home with family. I will assume, if you are asking me here that this is not an option for you. Here were my observations while at Gulf Wars XIX. First let me say, the SCA is not a babysitter, and while activities may be provided for some age groups, parents should help for a few hours to help share the burden of the activities.
 - a. **Activities-** From page school to youth combat there were activities for kids 6 and up. Check the schedule when you get to an event, for more information about children’s activities.
 - b. **Parental Rotation-** I saw several parents with toddlers on their hips watching the fighting while their other half was on the field. After the fighting, the other would take over while the first went to classes.
 - c. **Babysitting pool-** This would take some work and planning on your part before the war, but getting with other parents and sharing the babysitting could be an option. Keep in mind that you are ultimately responsible for your child on site and care must be taken with who you leave your child with.

2. **How do you pick a persona?** I have asked several people while at war this question. You would be surprised how similar the answers were. The things that most often draw a person to a particular time period or culture are:
 - a. **Family background-** Many people began their journey into the SCA researching their own family history. This leads them to recreating “in their ancestors footprints” as it were.
 - b. **Comfortable Clothing-** I must admit, this is one of the reasons I picked the time period and culture I did.
 - c. **Beautiful Clothing-** Later period clothing can be beautiful, with many layers, colors and textures. Pretty lace, magnificent brocades, just like playing dress up.
 - d. **Cultural Activities-** Ever tried something, and just loved it? Well for many people this leads them to study the cultures the activities come from. Weather belly dancing, martial arts, European dance, or some other activity, this can be a beginning for any persona.
 - e. **Language-** Did you learn a language in high school or college? Try studying the history and culture around that language.
 - f. **A historical event-** This is probably the least stated of any I heard, but a few people told me they were attracted to a particular event, a battle, rebellion, crusade, etc. They wanted to play someone who lived through that experience.

To sum this one up, the inspiration for your persona should be just that inspiration. If it moves you to learn, play, get involved, and recreate then do it. If you have not found that driving force, other than having fun, that’s ok. Generic European or Asian will do fine. My one suggestion is interact with as many people as possible. Dabble in as many A&S activities as you can. Eventually, the inspiration will come, and if it never does, you still had fun, and isn’t that why we really do this?





SAINTS DAY CALENDAR

April 10th is the calendar date for Fulbert of Chartres. Fulbert studied in Rheims, though he was born in Italy in the mid-10th century. Fulbert became the star student of the mathematician and philosopher Gerbert, who later became Pope Sylvester II. He was sent to Rome with Gerbert and following the death of Pope Sylvester II, Bishop Odo of Chartres made Fulbert the chancellor of the cathedral in Chartres. Through recognition of Fulbert's work, Chartres became a center for study in France, attracting scholars from throughout Europe. Eventually he was made bishop of Chartres. Sadly the cathedral was destroyed by fire almost immediately after his consecration as bishop. He rebuilt the cathedral and today his Romanesque steeple still is visible, though much of the cathedral now comes from later construction efforts. Fulbert considered himself as 'the tiny bishop of a very great church'. He died in 1029.

LESSONS IN HERALDRY

The Cover Letter of many of the monthly LoAR will include rulings and clarifications made by the Laurel, Wreath, and Pelican Sovereign/Queen of Arms. The Cover Letter for the November 2009 LoAR printed December 22, 2009, contains a change from the Laurel Queen of Arms within the Rules for Submission regarding Registered Names and the use of the Grandfather Clause by branches (groups) to honor past members with an Order name.

From Laurel: Extending RfS II.5, Registered Names

As our Society ages, it is becoming more and more apparent that we need to find a way to honor those whose footsteps paved the way and whose hands shaped our Society. One thing we can do is to allow orders to be named for these treasured individuals. As our understanding of names and naming practices have advanced over the years, many of the names of these individuals can no longer be registered. Following discussion of the rules change to the Grandfather Clause allowing branches to honor a past member with an order name in the Cover Letter to the March 2009 LoAR, the final wording is as follows. Italicized text is the addition or change in wording:

New wording for RfS II.5:

Once a name has been registered to an individual or group, the College of Arms may permit that particular individual or group to register elements of that name again, even if it is no longer permissible under the rules in effect at the time the later submission is made. This permission may be extended to close relatives of the submitter if the College of Arms deems it appropriate. *In addition, this privilege may be extended to a branch in whose territory the individual lives or has lived, or with which the individual is closely associated. In general, branches will be expected to use only elements from registered primary names of individuals.*

New wording for the Admin Handbook, IV.C.2 Documentation:

Documenting evidence must be included for all name elements, constructions, and patterns, as well as any non-standard armorial elements or practices. Such documentation must include references to specific pages and/or entries in the source material. Citations must be sufficiently complete to allow identification of the source and its usefulness, which generally includes author, title, and publication information (for print sources) or URL (for online sources). Except for documentation from items in Appendix H (the No-Photocopy List), such documentation must include copies of cited source material. While the kingdom college and College of Arms may assist with research and documentation, the submitter bears responsibility for providing documentation for all submissions.

Documentation must also be presented for any elements allowed under the mundane name allowance or by mundane relationship under the grandfather clause. *For branch submissions relying on grandfathered elements of personal names of individuals, the branch must document both the individual's relationship to the branch and the owner's permission to use the name element.*

So what does this mean for us? While we were a part of the Kingdom of Meridies, the Kingdom renamed or created Orders in honor of two individuals. The first was the renaming of the Order of Jerome to the Order of the Athanor. This was in honor of Master Johannes the Black of the Athanor, the athanor being the primary charge on his device and the first registration of that charge in armory within the SCA. The second was the creation of the Order of the Duvant Cross. This was in honor of Count Francois Duvant (name registered as Francois duVent), Knight of the Realm, and first Prince of Meridies. Is either of these Order names registered? The Order of the Athanor was registered to the Kingdom of Meridies in December 1996. The athanor is an item and while it was also an element of Master Johannes' name, the Order name was registered following rules of naming orders after things (Order of the Garter). The Order of the Duvant Cross is not registered. Again this Order name is following the rules of naming an order after an item (a cross). Duvant is just an adjective describing the cross. So to register Duvant Cross as an Order name, we would have to show period practice of use of a name or location to describe an item in an Order name, as Duvant presumably is documented as a French surname or location. If Duvant cannot be documented (it was a 'created' surname based on period examples but would not be registered now), then we still need to show that its use to describe the cross as a name or location is period in naming practices of Orders. Then we would have to use the grandfather clause, documenting the relationship of Francois Duvant to the Kingdom of Meridies (very easy to do) and documenting the owner's permission to use the name element (hard to do if there is no longer a way to contact the owner – impossible to do if the owner is dead). However, the Order of the Duvant Cross was created while Francois Duvant was alive. As such, there probably is a way to document his permission of the use of his surname in the creation of the Order name at that time. And at time of creation it would have behooved the Kingdom to submit the Order name for registration.

So, again, what does this mean for us? Let's pretend that on the fifth anniversary of the Kingdom of Gleann Abhann the Crown decides to create an Order in honor of Rhiannon the Scribe (we'll pretend her name was registered in June 1980). Recently (during 2009) names that were SCA compatible were declared to be no longer registered. We will say that Rhiannon is the name of a Welsh goddess, never shown to be used in period as an actual person's name. Without any documentation of the name used by people in period, Rhiannon will no longer be registered. However the Kingdom of Gleann Abhann decides to create the Order of Rhiannon in her honor. To register this

name (assuming no conflicts and that it follows period practice of Order names named after individual's), the grandfather clause has to be used, because there is no way to document Rhiannon as a period name. The Kingdom thusly must provide documentation of the relationship of Rhiannon the Scribe to the Kingdom of Gleann Abhann (in this fictional example she was the first Warlord, first Princess in her own right, and first Queen in her own right – this means she fought in the tourney and won). The Kingdom must also provide the owner's permission to use the name element. Rhiannon the Scribe writes a letter giving permission to use her first name 'Rhiannon'. With these two items, the Kingdom can now use the grandfather clause to register the Order name, Order of Rhiannon (assuming no conflicts, etc, etc.). And of course, Principalities and Baronies, which also may register Order names, could do the same.

If you have a particular heraldry question you would like answered in "Lessons in Heraldry", please let me know! I may not know the answer but will try to find an answer that helps.
